The Survivor Advisory Council will be comprised of 4-6 survivors of sex and labor trafficking. Each member's unique perspectives and expertise will help to develop survivor-informed service provision, provide input on training, and intervention development. Members will also participate in outreach, public awareness, and coalition-building activities to assist with identifying needed resources and services throughout the state that meet the needs of youth impacted by both sex and labor trafficking.

Meetings will occur quarterly over a three-year period and survivors will be paid for their time on the council and as training co-facilitators.

#### **Objectives**

- Public Awareness/Training- provide input on training development, implementation, and have the opportunity to serve as a co-trainer for all University sponsored human trafficking trainings.
- Survivor-Informed Service Provision

   collaborate with systems and service providers to advise on matters related to service delivery to ensure that services for survivors of trafficking are trauma and survivor centered.
- **Coalition-Building** assist with developing partnerships and collaboration between systems and service providers that work with survivors, including Maryland's Regional Navigator programs.

# Maryland's Child Sex Trafficking Regional Navigator Program

Part of our work under the Maryland Human Trafficking Initiative, is to support training and technical assistance across jurisdictions to improve outcomes for child victims of trafficking. Towards the end of 2020, PARI began providing enhanced technical assistance to Maryland's Child Sex Trafficking Regional Navigator Programs (RNPG).

The RNPG was developed after Governor Hogan signed into law the Child Sex Trafficking Screening and Services Act of 2019. The law requires law enforcement agents and local Departments of Social Services who have reason to believe a child/young adult (up to the age of 24) is a victim of sex trafficking to notify a Regional Navigator in their jurisdiction or region to obtain needed services for the child. The Governor's Office of Crime Prevention, Youth, & Victim Services oversees the RNPG and releases the notice of funding availability. As of November 2020, nine organizations have been awarded funding to develop RNPG within 10 jurisdictions. By January 2022, Maryland is committed to having RNPG assigned for all 24 jurisdictions.

PARI's technical assistance efforts have included coordinating trainings and presentations, as well as developing a learning community model to support collaboration and resource sharing across programs.

In March, PARI partnered with Alicia Aiken, Director of the Confidentiality Institute, to provide a training on how to navigate VOCA confidentiality guidelines while engaging in collaborative

partnerships with multi-disciplinary teams and Local Social Services/Law Enforcement providers.

The training, "Confidentiality, Consent, & Collaboration," highlighted the need for individualized approaches for release of information processes that honor the youth's request for what information is shared on their behalf and to whom that information is shared with.

# Maryland Experts Share Anti-Human Trafficking Models Addressing Fastest Growing Criminal Industry in U.S.

ANNAPOLIS, MD—The Governor's Office of Crime Prevention, Youth and Victim Services yesterday joined First Lady Yumi Hogan for the Global Human Trafficking Summit hosted by the Louisiana First Foundation and presented by the State of Maryland. Experts from Maryland shared the State's models to end human and child trafficking with nearly 400 advocates from across the globe.

"My heart aches for all victims of human trafficking and their families. These victims are like our sons and daughters, my grandchildren, and students," said the First Lady. "I cannot believe human trafficking and modern slavery are happening right next to us, in our own backyards. This is not about someone else. This is about us. It is our problem. This is the reason why we all should stand up and work together to combat human trafficking not only in the state of Maryland, but across the country and the world."

Louisiana First Lady Donna Edwards is passionate about ending

human trafficking, and through her platform, the Louisiana First Foundation, she has been hosting the Global Human Trafficking Summit since 2017.

#### The Institute's Nadine Finigan-Carr, PhD, Honored with Prevention Research Early Career Award



Nadine Finigan-Carr, PhD, School of Social Work Research Associate Professor and School of Medicine Associate Professor, was recently awarded the Society for Prevention Research Early Career Preventionist Network's 2021 John B. Reid Early Career Award. The Award is presented annually to someone who has shown a commitment to prevention science through outstanding contributions to research, policy, or practice. Nominees are early career scientists within ten years post terminal degree.

Finigan-Carr, in addition to her faculty positions, is also the Institute for Innovation and Implementation's Deputy Director of the Ruth Young Center for Maryland where she leads the Prevention of Adolescent Risks Initiative. She is internationally recognized for her work in the prevention of human trafficking. Her rigorous research is focused on the application of behavioral and social science perspectives to contemporary health problems, especially those that disproportionately affect people of color. The results of her research have been published in more than twenty peer-reviewed publications and the 2017 publication, Linking Health and Education for African American Students' Success, focused on the ties between African American students' outcomes and their health.
